Weber Distribution applies a fuel surcharge to each shipment invoice, applying the Western regional fuel index on the date of the shipment within and between the states of CA, AZ, NV, OR, WA. Freight destined to or originating from all other contiguous states will be subject to the National Price Index.

The Federal Department of Energy Fuel Index as of Monday of each week provides the baseline for use for the next 7 days, beginning Wednesday, and continuing through the following Tuesday. This data is obtained and is publicly available at www.eia.doe.gov, or (202) 586-6966.
